DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

AQUACIDE 400 is used to control algae, and bacteria in redirculating commercial and industrial water cooling towers. Prior toils use, systems must be cleaned to remove algal growth, microbiological slime, and other deposits. An initial slug addition of 5.1 to 10.2 fluid ounces of AQUACIDE 400 per 1000 gallons of water is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 1.7 to 10.2 fluid ounces of AQUACIDE 400 per 1000 gallons of water should be employed every 1 to 5 days, or as needed.
