An initial slug addition of 5.1 to 10.2 fluid ounces of Carbicide-M per 1000 gallons of water is recommended. Repeat initial desage until control is evident.

Subsequent slug additions of 1.7 to 10.2 fluid ounces of Carbicide-M per 10*9 gallons of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump of water cooling towers.
