

HYDROCO M-195 is used to control bacteria, algae, and fungi in recirculating commercial and industrial water systems. To its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of 48 fluid ounces of HYDROCO M-195 per 1000 gallons of water to provide a concentration of 48 to HYDROCO M-195, based on the water in the system, is recommended. Repeat initial dosage of 1.53 to HYDROCO M-195 per 1000 gallons of water to provide a concentration of 120 parts per million of HYDROCO M-195.
