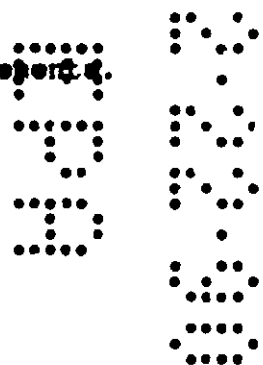

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Remove protective cap. Aim spray opening away from persons. Push button to spray.

WASPS:

Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat if necessary. Application should be made in the evening, when the insects are at rest. Stand at least 10 feet from area you are spraying.

CRAWLING INSECTS:

Cockroaches, Earwigs, Spiders, Grain Mites, Sow-bugs, and Centipedes: Spray thoroughly into hiding places (cracks, crevices, moist areas, openings around sinks and pipes, underneath refrigerators, baseboards and storage areas). Spray directly onto insects if possible; repeat as necessary.

ANTS:

Spray trails, nests and points of entry. Spray onto ants if possible; repeat as necessary.

DISPOSAL

Do not reuse empty container. Wrap and place in trash collection.

PRECAUTIONARY STATEMENTS

Harmful if swallowed. Avoid contamination of feed and foodstuffs. Remove pets, birds and cover fish aquariums before spraying. In case of skin contact, wash immediately with soap and water. In case of eye contact, flush with plenty of water. If irritation develops or persists, obtain medical attention. Wash thoroughly after using.
