**STORAGE AND DISPOSAL**  
**Prohibitions:** Do not contaminate water, food, or feed by storage, disposal, or cleaning of equipment. Open dumping is prohibited. Avoid contamination of feed and foodstuff. Do not store near food or feed products. Store out of the weather.

It is recommended only for general weed control around buried cable closures, telephone booths, cross-connect boxes, transformer pads and fire plugs. The duration of non-productivity is dependent upon rainfall, soil type, and other conditions.  
**RATE:** Apply at 0.5 to 1 pound per 100 square feet. Repeat spot treatment may be required when deep-rooted perennial weeds are present.  
**HOW TO APPLY:** Apply, as furnished, with a shaker-type applicator or with any equipment which will distribute the chemical uniformly over the area to be treated.  
**WHEN TO APPLY:** To obtain best results, apply to the ground where it will be absorbed by the roots. Applications made early in the season have been found to give results superior to application at a later seasonal date. Maximum effectiveness in arid regions is obtained when application is made just prior to the rainy season.
