DIRECTIONS FOR USE

It is a violation of Federal law to use this product in manner inconsistent with its labeling.

FOR WASP, HORNET, YELLOW JACKET AND BEE (Including Africanized Honey Bees) CONTROL

Spray from upwind position, from a distance of 8-10 feet. Spray until nest is thoroughly covered and all emerging insects are contacted. To prevent insects from falling on skin and clothing, do not stand directly under nest.

FOR ANT AND FIRE ANT CONTROL (MOUND CONTROL): Install delivery tube on spray can. Begin spraying, then insert delivery tube into ant mound while maintaining spray delivery. Insert in several locations to maximum possible depths. Remove delivery tube, reinstall spray nozzle and spray external areas of the mound thoroughly.

FOR FORAGING ANT CONTROL: Use spray nozzle, spray directly on ants. Spray hills and runways. Repeat as necessary.

OTHER USES - OUTDOORS ONLY: For control of Clover Mites, Crickets, Earwigs, Fleas, Flies, Millipedes, Moths, Scorpions, Spiders (including Black Widow and Brown Recluse), Roaches and Brown Dog Ticks: Spray infested areas thoroughly, including outside surfaces of screen frames, doors, window frames, foundations, patios, or other places where insects may enter or congregate. Repeat treatment as necessary. Do not spray vegetation.

FOR CONTROL OF ROACHES, ANTS, WATER-BUGS, SCORPIONS, SILVERFISH, SPIDERS (including Black Widow and Brown Recluse) AND CRICKETS - INDOORS: Spray heavily into all cracks, around baseboards and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks and stoves. Spray other localized areas infested with these pests. Repeat treatment as required. Do not allow children to contact treated surfaces until surfaces are completely dry. Do not spray where food is exposed.

FOR CONTROL OF ROACHES AND SPIDERS, (including Black Widow and Brown Recluse) IN MANHOLES: Using spray nozzle, spray directly on pests or localized areas infested with these pests. Repeat treatment as necessary.
