The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

1. Delete the following statement from the product label:

New Formula: Contains No R-11

2. Reinstate the Storage and Disposal section which was contained in the product label which was stamped "ACCEPTED" dated January 17, 1991.
3. Although we would prefer inclusion, we have determined that it is acceptable to remove the statement "If you go to a doctor, take this repellent with you" from the product label. You may remove this statement from your label without submitting an amendment.

**Read Directions and
Precautionary Statements Before Using This Product.**

STORAGE: Store in a cool area away from heat or open flame.
DISPOSAL: Replace cap, wrap container and put in trash collection. Do not puncture or incinerate.

Hold unit 8-12 inches from skin or clothing while spraying. Use a slow sweeping motion, applying just enough repellent to cover exposed skin and/or clothing. Avoid overexposure. Frequent reapplication and saturation is unnecessary for effectiveness. Do not spray directly on face. Apply on face by first spraying small amounts in palm of hand and spreading on face or neck. Do not apply to eyes and mouth nor to the hands of young children. After returning indoors, wash treated skin with soap and water.

FOR CLOTHING: For extra protection from crawling ticks, chiggers and fleas, use extra spray along all openings of clothing, such as neck band, waist band, pant and sleeve cuffs, sock tops and other areas where these insect may crawl under clothing. For added protection from ticks, wear shoes or boots, tuck pants into socks. Wear long sleeved shirt tucked into pants. Inspect often for ticks. Do not use under clothing. Wash treated clothing.

PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals

CAUTION: Harmful if swallowed. For external use only. May cause eye irritation. Do not get in eyes or on mouth. Avoid breathing spray mist. Do not spray in enclosed areas. Statement of Practical Treatment
