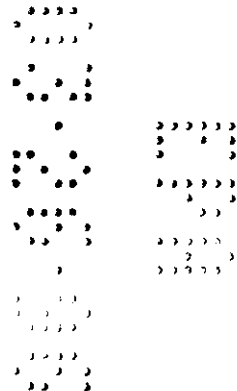

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product is for sale to and use by utility industry personnel and commercial or industrial service personnel only.

For use in and around buried cables, telephone cable and cable television pedestals, pad-mounted electric power transformers, air conditioning units and underground vaults. Do not open contents until ready for use.

[Directions for Use for product packaged in 4 oz. Mylar bags:]

Open Mylar plastic bag and pour entire contents (4 oz.) directly into and around buried closure or hole. Lock closure or set pole immediately to prevent access. One bag will treat buried closures up to size 12" x 12" (1 sq. ft.).

[Directions for Use for product packaged in 100 oz. containers:]

Open the applicator dispenser lid two (2) notches and shake (broadcast left to right) the insecticide onto the ground, covering the area of the pad location, plus a two foot perimeter around the outside of the pad location. This container will cover up to a 100 sq. ft. area (an area 10' x 10'). Container holds the equivalent of 25, 4 oz. bags of Rainbow Fire Ant Killer. Plastic barrier required for poured-in place pads. Prior to pouring concrete, cover insecticide-treated surface with plastic barrier. ~~Refer to internal company policy for detailed instructions.~~

STORAGE: Store in a clean, dry place. Protect container from rupture during storage and transport. If contents are spilled, sweep or scoop up material and place in another clean, dry container for reuse or disposal in accordance with this label. **DISPOSAL:** Do not reuse empty container. Securely wrap and discard in trash.
