Generic data requirements that have been identified in the RED as confirmatory data for the active ingredient contained in the subject product will continue to be tracked and assessed in the Agency's continual reassessment of pesticides.

**Label Comments:**

- On page 1, add the word “only” so the second statement under the product name reads, “For use in and around telecommunications, power, utilities, and railroad systems equipment **only**.” The product must be clearly labeled only for the registered sites.
- On page 1, **delete all references to control** (i.e., “controls,” “also controls,” “to maintain control”). In order to support control claims, additional residual data using aged tags must be submitted.
- On page 1, **delete all references to “bees”** from the label. This use requires additional efficacy data.
- On page 1, **delete all references to repellency** (i.e., “Repels continuously” and “It repels fire ants and cockroaches from enclosed utility equipment”). The data and data summaries submitted with the application for reregistration do not support repellency claims.
- The sale and use of this pesticide can not be restricted to the listed personnel, as the product is not classified as a restricted use pesticide. Therefore, under the Directions for Use, revise the second paragraph so it reads, “This product is **intended** for sale to, use, and storage by utility and commercial or industrial service personnel. For use in and around telecommunications, power, utilities, and railroad systems equipment **only**.”
- Regarding the note on the formatting of the First Aid box on page 2, it is strongly recommended that for consistency and clarity, you format the information as specified in PR Notice 2001-1.

**Rainbow Insect Tag** is a self-contained, continuous release insecticide. It kills and controls ants (except Harvester, Pharaoh and Carpenter), bees, crickets, earwigs, millipedes, silverfish, sowbugs and spiders (including Black Widow and Brown Recluse). It repels fire ants and cockroaches from enclosed utility equipment. Repels continuously.

Do not open until ready to use. Open outer package (do not remove tag from holder), secure tag(s) with ties. Due to various equipment sizes, the amount of product may vary, however not more than two tags per three cubic feet is recommended. Use in interior areas at points of entry. Do not place product where it will interfere with moving parts of equipment. Do not place tag on outside of equipment or in exposed locations where direct contact with children, pets, food or clothing is likely to occur. To maintain control, monitor effectiveness and replace tag(s) when effectiveness diminishes.

**Storage and Disposal**
