### PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

#### CAUTION

May be harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes or clothing should be avoided. Wash thoroughly after using. Avoid contamination of food, utensils and food preparation areas. Do not spray animals. #### GENERAL CLASSIFICATION

DU COR CONCENTRATED FLY INSECTICIDE is for use around buildings which house domestic pets, around yards, in land fill dump areas, around meat processing plants or wherever flies or larvae present a problem.

### HOW TO USE:

Dilution table.

CONCENTRATE:	WATER TO MAKE:
8 ounces	2-1.2 gallons
1 quart	12 gallons
2 gallons	100 gallons

Apply at the rate of 1 gallon diluted spray per 1,000 square feet on painted surfaces and 2 gallons per 1,000 square feet on unpainted surfaces where flies alight or congregate.

Use 3 gallons of concentrate with 40 pounds of sugar as a bait if fly population is severe. For land fill areas manure or loafing sheds, apply concentrate at the rate of 2 gallons with 20 pounds of sugar per 100 gallons of water.
