The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the product label is enclosed for your records.

1. Revise the phrase Practical Treatment to read as follows: **STATEMENT OF PRACTICAL TREATMENT.**
2. Insert the following precautionary headings and text directly above the subheading **STATEMENT OF PRACTICAL TREATMENT:**

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS
CAUTION**

Harmful if swallowed. May cause eye and skin irritation. Keep out of reach of children and domestic animals.

3. Revise the **STATEMENT OF PRACTICAL TREATMENT** to include the following text:

IF SWALLOWED: Contact a physician or Poison Control Center immediately.

4. It is not necessary to list the inert ingredients on the product label.

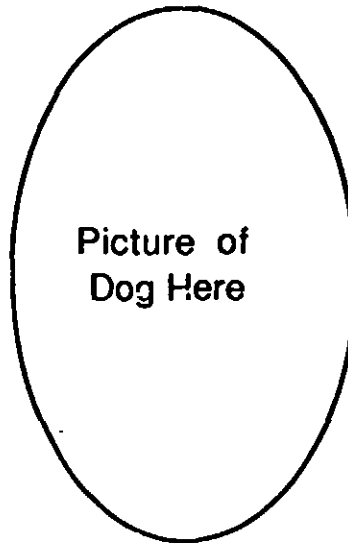
