The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. The Agency, has also completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the MGK 264, Piperonyl butoxide, and Pyrethrins REDs, and has concluded that your submission is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

NOTE: This product is **not** yet being reregistered under section 4(g) of FIFRA.
