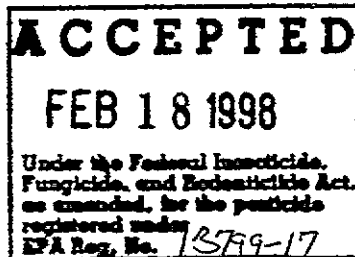

**DIRECTIONS FOR USE**

Wet animal's coat thoroughly and rub with soap. Work up a good lather all over, including legs and feet. Once animal is fully lathered with the soap, allow 3 minutes to kill fleas, ticks and lice before rinsing. Rinse with plain water. Allow to dry naturally or wipe with a clean towel. Use only as directed. Repeat weekly if necessary. Do not use on puppies under 12 weeks of age. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals or animals on medication. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.
