The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

Delete Healing Remedies. This is a drug claim that is regulated by the Food and Drug Administration.

Delete "mild" from the marketing claims. This is an implied safety claim and detracts from the Precautionary Statements.

Delete "long lasting." Pyrethrins are not long lasting.

Delete claims that the product "repels flies, mosquitoes and gnats." Pyrethrins have no repellent properties.

Revise the Precautionary Statements to read as follows: Hazards to Humans Caution Keep out of Reach of children. Harmful if swallowed. Causes moderate eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco.

Add to the emergency telephone number the following: After 5 PM call your poison control center.

Place a subheading entitled "Use Restrictions" under the Directions for Use. Move the following revised statements under this subheading:

Do not apply to puppies less than 12 weeks old. Consult a veterinarian before using this product on medicated, debilitated, aged, pregnant, or nursing animals. Sensitivities may occur after using any pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

Please note that notices of availability of the EPA's reregistration eligibility documents (REDs) for products containing pyrethrins, piperonyl butoxide and N-Octyl Bicycloheptene Dicarboximide were published in the Federal Register on July 26, 2006.
