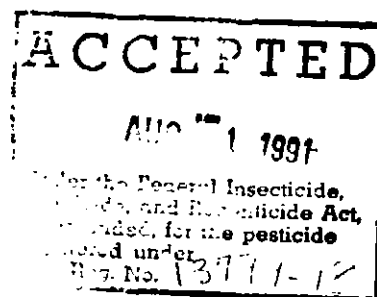

Rug-Bug can be used for pet beds, carpeting, draperies and all upholstered areas. Rug-Bug is water-based and non-staining.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

HOW TO USE RUG-BUG:

Rug-Bug to Kill Fleas & Ticks: Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as necessary. Fresh bedding should be placed in animal quarters after spray has dried. Do not spray animals.

Rug-Bug to Kill Carpet Beetles and Dermestids: Spray along baseboards, edges of carpeting, under carpets and rugs, under furniture, in closets, on shelving, and in other places of harbourage. Repeat as necessary.

Rug-Bug Spot Treatment: To kill ants, roaches, crickets, silverfish, sowbugs, spiders and earwigs; spray into cracks, crevices, around baseboards, and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Contact directly as many insects as possible. For ants, spray trails and places where ants enter premises. Repeat as necessary for control. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

Application of this product in the food areas of food handling establishments other than a spot treatment is not permitted.

General: Use as a spot treatment to control cockroaches, waterbugs, silverfish, ticks, fleas and other insects listed above. Apply this product to localized areas where pests are found or may occur. Spray surfaces until wet.

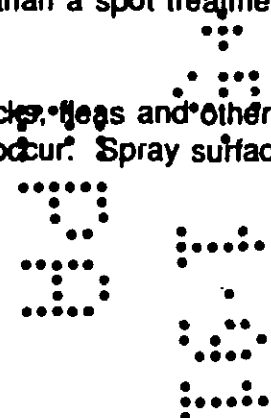
Precautionary Statements

Hazards to Humans and Domestic Animals

CAUTION

Harmful if swallowed, inhaled, or absorbed through skin. Avoid breathing spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes and clothing. In case of contact, immediately flush skin and eyes with plenty of water. Wash thoroughly with soap and water after handling. If poisoning occurs, get prompt medical aid.

PRACTICAL TREATMENT

- IF IN EYES: Flush with plenty of water. Get medical attention if irritation persists.
- IF ON SKIN: Remove contaminated clothing. Wash skin with soap and warm water. Get medical attention if irritation persists.
- IF INHALED: Remove to fresh air if effects occur, and call a physician.
- IF SWALLOWED: Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Call a physician.

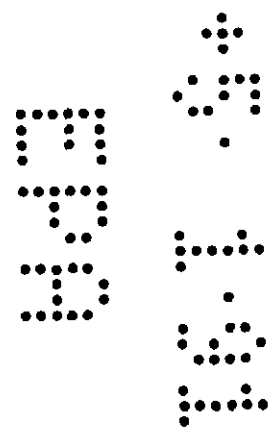
NOTE TO PHYSICIAN: Clorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

Do not apply directly to food. In commercial food handling facilities, cover or remove any food or food processing equipment during application. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Cover exposed food.

Physical Hazards

- Storage: Store in a cool dry area away from heat or open flame.
- Disposal: Do not re-use empty container. Wrap container and put in trash collection.
