Submissions dated March 19, 1992

The labeling amendments referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, are acceptable subject to the comments listed below. Submit one (1) copy of the respective product labels prior to releasing the products for shipment.

Regarding product 13799-10:

1. Add the heading PRECAUTIONARY STATEMENTS and the subheading HAZARDS TO HUMANS AND DOMESTIC ANIMALS to the rear panel of the label directly above the words CAUTION: KEEP OUT OF REACH OF CHILDREN. DO NOT SWALLOW.

2. Add the subheading STATEMENT OF PRACTICAL TREATMENT directly above the section which begins "If on skin:".

3. Delete the phrase "used by professionals" as this product is not restricted for use by veterinarians only.

Regarding product 13799-24:

Delete the phrases "Used by professionals" and "EXTRA STRENGTH".

Regarding product 13799-25:

1. Delete the phrase "Used by professionals" and the words "Advanced Formula" from the product label, and revise the product name to delete the term "Super". The product name must be revised in such a way that it is distinctive from the other Four Paws registered pesticide products.

2. Add the heading PRECAUTIONARY STATEMENTS and the subheading HAZARDS TO HUMANS AND DOMESTIC ANIMALS to the product label directly above the phrase CAUTION: KEEP OUT OF REACH OF CHILDREN. DO NOT SWALLOW.
