Dear Mr. Birk,

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

1. Remove the term "PRECAUTIONARY LABELING", and place all precautionary text under the subheading "HAZARDS TO HUMANS AND DOMESTIC ANIMALS. The text should include the signal word "CAUTION" followed by the statement: HARMFUL IF SWALLOWED. WASH THOROUGHLY WITH SOAP AND WATER AFTER HANDLING. CAUSES MODERATE EYE IRRITATION. AVOID CONTACT WITH EYES OR CLOTHING.

2. The FIRST AID subheading text should be modified to include the following:

IF SWALLOWED: CALL A PHYSICIAN OR POISON CONTROL CENTER. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting.

IF IN EYES: FLUSH EYES WITH PLENTY OF WATER. Call a physician if irritation persists.

3. The child-hazard warning statement, CAUTION: KEEP OUT OF REACH OF CHILDREN, should be removed from the Precautionary Statements and separately displayed on the front panel. Refer to 40 CFR 156.10 (h)(1) and (h)(2) for further guidance.

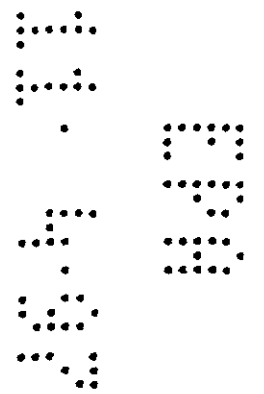
