Subject: Amendment - Addition of Fragrance and Revised Labeling Four Paws[®] Protector[®] EPA Registration No. 13799-26 Your Application Dated August 26, 1991

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

1. In the ingredient statement, an open parenthesis should be inserted in front of the chemical name for **Permethrin** as follows "[(3-Phenoxyphenyl)....".

Submit five copies of your final printed labeling before you release the product for shipment. A stamped copy of the labeling is enclosed for your records.

The revised Confidential Statement of Formula (CSF) referred to above, submitted in connection with registration under Federal Insecticide, Fungicide, and Rodenticide Act, as amended, to add Fragrance #2945 is acceptable provided you make the following changes to the CSF.

- 1. Specify the purpose of the fragrance in column #15.
- 2. Specify the upper and lower certified limits for all components including the inert ingredients and the Related Reaction Products from Permethrin in column #14.
- 3. The total weight of the batch should be specified in block #17.
