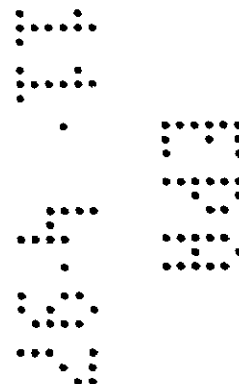

Four Paws Protector Kills fleas and ticks quickly and easily. Four Paws Protector will control fleas for up to 14 days on dogs and cats and will control ticks up to 4 days on dogs and 9 days on cats.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Hold container upright. Shake well before using. Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including the legs and under the body. Fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet ticks thoroughly. Do not spray in face, eyes or on genitalia. Repeat as needed. For cats, apply at the rate of one second per pound of body weight. For dogs, apply at the rate of two seconds per pound of body weight for thin or short haired dogs and up to 8 seconds per pound of body weight for heavy or long-haired dogs. Do not use on puppies or kittens under the age of 12 weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

Helpful Hint: To control reinfestations, weekly applications with Four Paws Protector are recommended.

PHYSICAL AND CHEMICAL HAZARDS

Do not use or store near heat or open flame.

FIRST AID

IF SWALLOWED: Drink one or two glasses of water and induce vomiting by touching the back of the throat with finger. Repeat until vomit fluid is clear. Call a physician immediately. Do not induce vomiting or give anything to an unconscious person.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.
