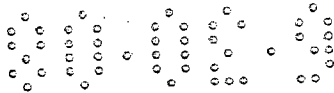

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Hold container upright. Shake well before using. Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including the legs and under the body. Fluff the hair as you spray so the spray will penetrate to skin. The spray should wet ticks thoroughly. Do not spray in face, eyes or on genitalia. Repeat as needed. For cats, apply at the rate of one second per pound of body weight. For dogs, apply at the rate of two seconds per pound of body weight for thin or short-hair dogs and up to 8 seconds per pound of body weight for heavy or long hair dogs. Do not use on puppies or kittens under the age of 12 weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

STORAGE AND DISPOSAL

STORAGE: Store only in a cool, dry place inaccessible to children and pets, away from heat and open flame. Store above 32°F and protect from freezing.
