DIRECTIONS FOR USE

For use in hotels, motels, homes, institutions, packaging and processing plants, seed houses, and horse stables.

SPACE SPRAY — To kill flies, mosquitoes and gnats. Close room or area to be treated. Shut off air-conditioner and ventilator system. Seal all open vents. Cover all food handling surfaces and cover or remove all food. Remove fish pets. Apply undiluted as a very fine mist space spray through manually operated equipment or with electrical and other powered applicators. Avoid staining by holding the spray nozzle at least five feet from objects. Direct the fine spray mist toward the upper corners of the room. Fill the room with a fine mist space spray, at the rate of 5 fluid ounces per 5,000 cubic feet. Leave room closed for one half hour. Ventilate thoroughly before re-entry.

CONTACT SPAYS — For control of roaches, ants, earwigs, grain mites, sowbugs, spiders and centipedes: Adjust sprayer to produce large wetting type spray particles. Direct spray to contact these insects in cracks and crevices in floors, baseboards, around pipes, behind cabinets, and other harbourages. Spray these infested areas until thoroughly wet. Repeat as necessary.

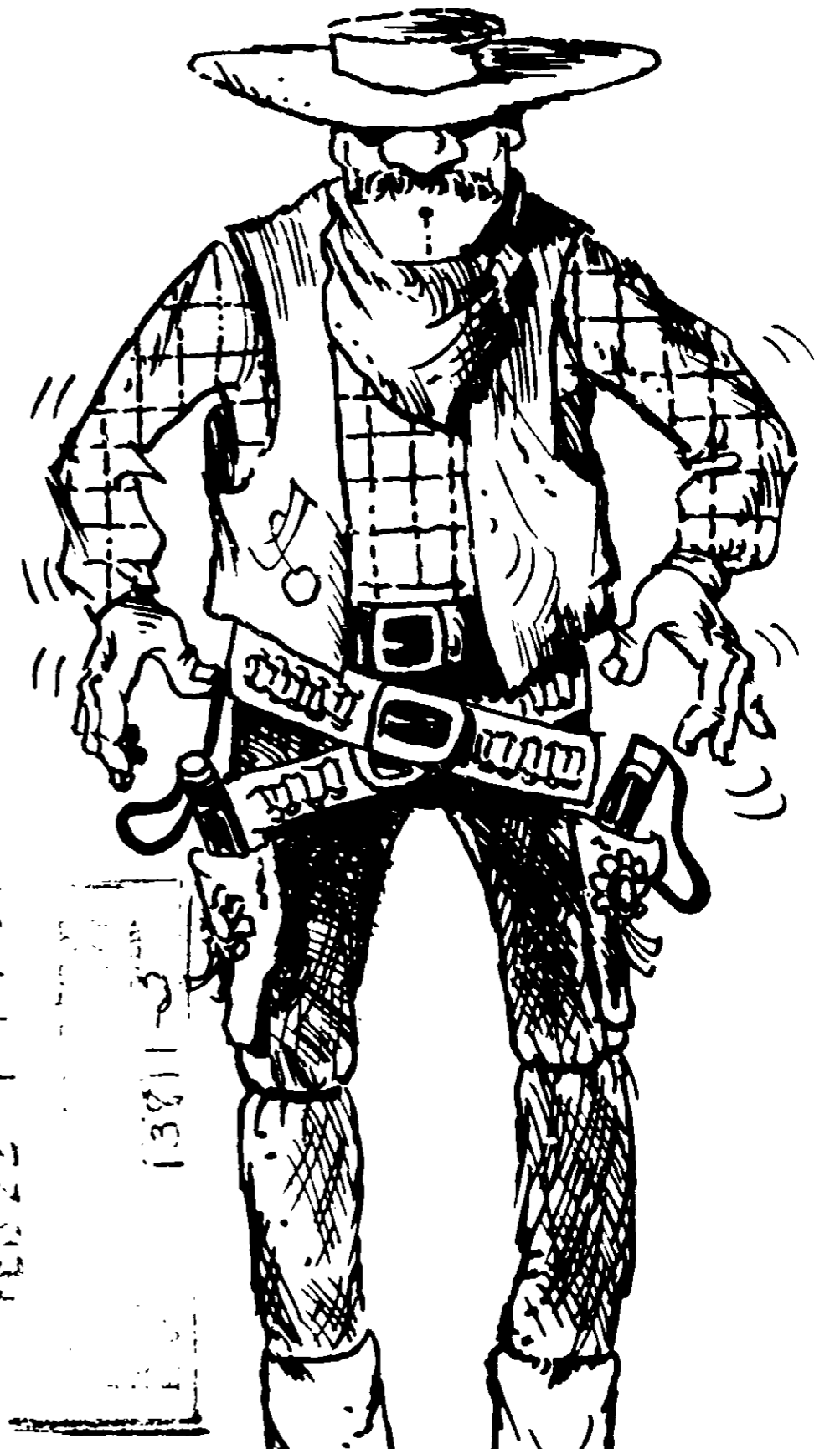
CAUTION

Food should be removed or covered during treatment. All food processing surfaces should be covered or thoroughly cleaned before using. Extinguish open flames before space spraying. This formulation is combustible. Do not store near open flame.

CONTAINER DISPOSAL — Crush used container and bury in non-cropland soil away from water. This formulation is toxic to fish. Avoid contamination of water.
