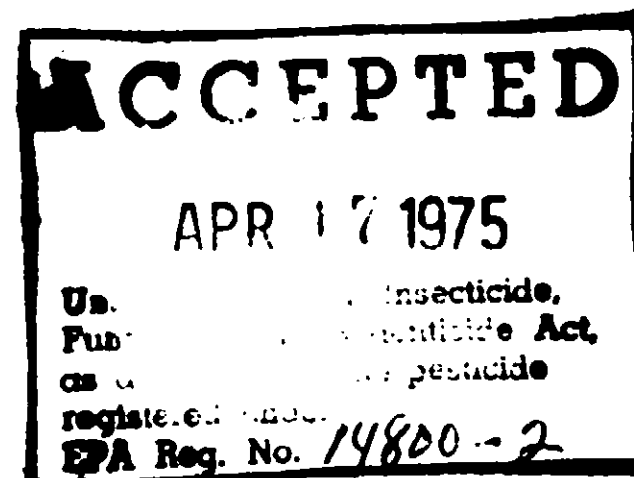
Micronized Copper Sulfur is a highly dispersible wettable powder with a particle size of less than 2 microns.

## DIRECTIONS

When mixing, add this product to a partially filled spray tank while agitating.

**SOYBEANS - Frogeye Leaf Spot, Brownspot, Pod and Stem Blight-** Apply as a spray at rate of 4 - 7½ lbs. in a minimum of 5 gallons of water per acre at 10 - 14 day intervals when disease appears. May be applied in conventional ground sprayers or as an aerial spray.

**WHEAT - Leaf Rust, Leaf Blotch, Glume Blotch -** Apply as a spray at 3 - 5 lbs. in minimum of 5 gallons of water per acre as an aerial spray at 10 day intervals when symptoms first appear.

**PEANUTS - Cercospora Leaf Spot -** Apply as a spray at rate of 7½ lbs. in dilute spray of 40 gallons of water per acre, or concentrate rate of 10 - 20 gallons per acre.
