

## DIRECTIONS

To make a 5% ready-to-use solution, mix one part of this concentrate with five parts by volume of a suitable petroleum solvent such as mineral spirits or kerosene.

As Penta Pres. 1-5 is a concentrate, do not use without diluting.

# **WOOD PRESERVATION**

After diluting as indicated above the ready-touse Penta Pres. 1-5 solution can be applied to lumber, poles, post and other wood products by a hot-cold bath process, by soaking, spraying, or brushing. The most effective treatment is obtained where deep penetration and high absorptions result. Soaking or a hotcold bath process gives better results than does spraying or brushing and should be used where possible. Fence posts should be barked and air seasoned until dry and then soaked 24 to 48 hours. The butts should be well treated. Lumber for steps, sills, etc. should be soaked for at least 12 hours. When the wood is not in ground contact, brushing or swabbing may be used. The joints should be thoroughly drenched.

The solution obtained by diluting this concentrate with five volumes of petroleum solution is a proven wood preservative and is especially recommenced for the use of termite exterminators and others wishing to protect buildings from the ravages of these insects. Wood treated with ready-to-use solution is not paintable. If it is desired to paint treated wood, Penta WR should be used.
