

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

BLACK ALGAE OUT

is used in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using BLACK ALGAE OUT.

For pools having just visible algae growth add an initial dose of 6 fluid ounces of BLACK ALGAE OUT per 1,000 gallons of water. For treatment of a pool with settled algae debris by cleaning. For treatment of a pool add initially 6 to 11 fluid ounces of BLACK ALGAE OUT per 10,000 gallons of water. Subsequent additions of BLACK ALGAE OUT per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains should require an initial dose of 1 to 2 fluid ounces of BLACK ALGAE OUT per 1,000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 0.2 to 0.4 fluid ounces of BLACK ALGAE OUT per 1,000 gallons of water.

BLACK ALGAE OUT should be made every 5 to 7 days after initial treatment. BLACK ALGAE OUT is compatible with chlorine chemicals and may reduce the amount of chlorine available.

BLACK ALGAE OUT can be used in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using BLACK ALGAE OUT.

However, do not mix BLACK ALGAE OUT with liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept out of the home and away from food.

DISPOSAL: Do not reuse empty container. Wrap in plastic and dispose of with clear water.
