DIRECTIONS FOR USE

To control ambrosia beetles in lumber add 2½ quarts of Chemtox-BHC to each 100 gallons of solution in the dip vat or tank. Chemtox-BHC may be added after the Chemtox-10 or Chemtox-L solutions have been prepared. Agitate thoroughly to form emulsion.

For lyctid beetle control add 4 gallons of Chemtox-BHC to each 100 gallons of stain control solution as described above.

Solutions to which Chemtox-BHC have been added should be agitated if allowed to stand for several hours undisturbed.

To control wood boring Beetles and Bark Beetles in logs add one gallon of Chemtox-BHC 28 gallons of kerosene, diesel fuel, or #2 fuel oil and mix thoroughly. Water can be used at above rate but protection to logs will not be as lasting. Logs should be sprayed within 24 hours after feiling. Spray thoroughly all parts especially cut ends and skinned places. One gallon of spray per 100 square feet of log area is required.
