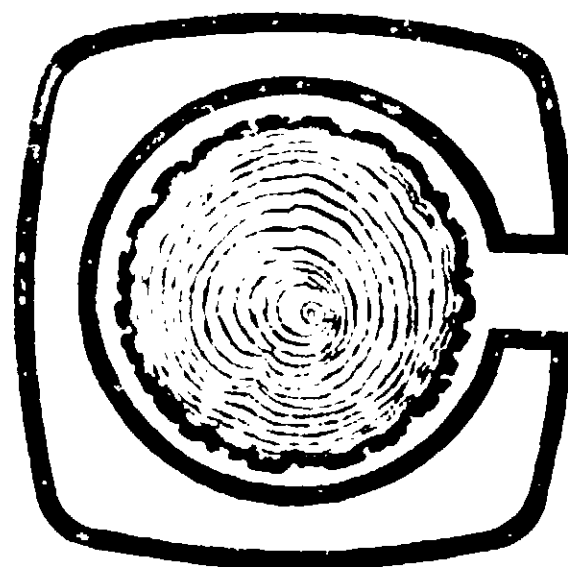

CHEMTOX-P-WP CONCENTRATE



Pentachlorophenol Wood Preservative Concentrate 1 to 10
For General Wood Preservation and Soil Poison

ACTIVE INGREDIENTS:

Pentachlorophenol	37.0%*
Other Chlorophenols	4.3%*

INERT INGREDIENTS: 58.7%

*Equivalent to 43% Technical Pentachlorophenol As Defined By Federal Specification TT-W-570

DIRECTIONS

To make a 5% ready to use solution, mix 1 volume of Chemtox-P-WP Concentrate with ten volumes of a suitable petroleum solvent such as diesel fuel or #2 fuel oil. Do not use the concentrate without diluting.

APPLICATION

For wood preservation Chemtox-P-WP can be applied to lumber, poles, posts and other wood products by the hot and cold bath process, by soaking, spraying, or brushing. Allow at least two liberal coats when using the brush or spray method. For maximum effectiveness deep penetrations and high absorption should be obtained. Fence posts should be debarked and seasoned until dry and soaked 24 to 48 hours. The butts should be treated well. Lumber products should be soaked at least 12 hours. Wood that is not in ground contact may be brushed or sprayed. The joints should be thoroughly treated. Wood treated with this product is not paintable.

For termite control, spray or soak the soil which has been removed from around the foundation of the building to a depth of 30" but not below the footing if this is shallower. The rate of application should be 5 gallons of 5% solution per 10 linear feet of trench up to 15" deep and 10 gallons of 5% solution per 10 linear feet for deeper trenches. Replace the treated dirt, respraying at 6" intervals as the earth is replaced. Do not spray on plants. Grass, trees, and shrubs within 3 feet of the trench should be removed or protected with tar paper.
