GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product inconsistent with its labeling.

Algae slime control - 10 is used in recirculating commercial and industrial water control systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 5.1 Algae slime control - 10 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.7 to Algae slime control 10 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water control systems.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Do not store in five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a container closed when not in use.

**PESTICIDE DISPOSAL:** Pesticide wastes are extremely toxic. Excess pesticide, spray mixture, or rinsate is a valuable commodity.
