DIRECTIONS FOR USE

It is a violation of Federal law to use this product inconsistent with its labeling.

Algae and slime control - 20 is used in recirculating commercial and industrial water control systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 3.3 Algae and slime control - 20 per 100 gallons is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 1.1 to Algae and slime control - 20 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water control systems.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in a cool, dry place. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a sanitary manner. Do not be absorbed in sawdust or sand and disposed of in a sanitary manner. Container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely toxic. If a spill occurs, absorb with appropriate material and dispose of in a sanitary manner.
