

FIRST AID: If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or, if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. Keep out of lakes, streams, or ponds. Permits may be required for discharges containing this pesticide into lakes, streams, ponds, or public water. For guidance, contact the regional office of the Environmental Protection Agency.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ALL PURPOSE ALGICIDE is used in swimming pools, exterior spas, whirlpools, hot tubs, and indoor effectiveness pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial fluid ounces of ALL PURPOSE ALGICIDE per 10,000 gallons of water. Subsequent additions of ALL PURPOSE ALGICIDE per 10,000 gallons of water. For treatment of a pool add initially 41 to 75 fluid ounces of ALL PURPOSE ALGICIDE per 10,000 gallons of water. Subsequent additions of ALL PURPOSE ALGICIDE per 10,000 gallons of water 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains require an initial dose of 8 to 12 fluid ounces per 1000 gallons of water. For treatment of a freshly installed hot tub, or decorative fountain, add initially 4 fluid ounces of ALL PURPOSE ALGICIDE per 1,000 gallons of water. Subsequent additions of ALL PURPOSE ALGICIDE per 1,000 gallons of water should be made every 5 to 7 days after initial treatment.

ALL PURPOSE ALGICIDE is compatible with chlorine chemicals and may reduce the amount of chlorine required. However, do not mix ALL PURPOSE ALGICIDE with liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept out of reach of children and away from food.

DISPOSAL: Do not reuse empty container. Write name and address on container.
