Dear Mr. Jackson,

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

1. Review of the file for this product indicates that there are no data to support the claim that the compound is "Recommended for puppies and kittens". Therefore this claim should be removed from the label.

2. Additionally, the label indicates " Do not use on puppies or kittens under 4 weeks of age. " No data appear in the file for this compound to support this claim. Therefore, this should be removed from the label. PR Notice 96-6 suggests that few products have data that would support a younger age than 12 weeks.

DOGS & CATS: Use as is, or dilute 1 part with 4 parts of water. Wet coat thoroughly with warm water. Apply shampoo and work well into the coat. Allow lather to stand for 10 minutes if fleas, ticks or lice are present (if heavily infested, use full strength). Rinse with warm water, dry and groom as usual. Repeat every 7 days, if needed.

Do not use on puppies or kittens under 4 weeks of age.

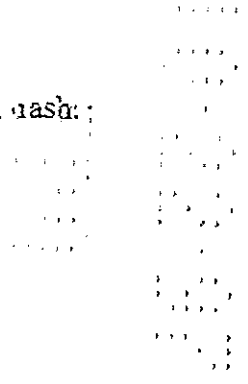
Consult a veterinarian before using this product on debilitated, medicated, aged, pregnant or nursing animals.

Disposal: Replace Cap. Wrap in several layers of newspaper and discard in trash.

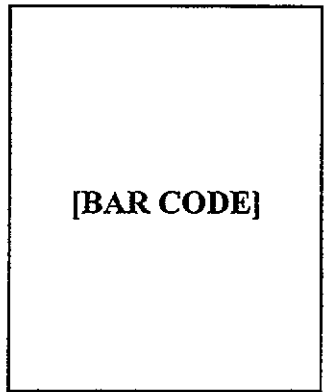
