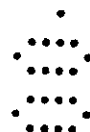
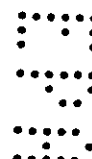

**HOLD CONTAINER UPRIGHT - SHAKE WELL BEFORE USING.** Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including under the legs and under the body. Fluff the hair as you spray so the spray will penetrate to the skin. Wet ticks thoroughly. Repeat every 7 days, if needed. For cats apply at the rate of 1 second per pound of body weight. For dogs apply at the rate of 2 seconds per pound of body weight for thin or short dogs and up to 8 seconds per pound of body weight for heavy or long haired dogs.

Consult a veterinarian before using this product on debilitated, medicated, aged, pregnant or nursing animals.

Do not use on puppies or kittens under 3 months of age.

**STORAGE & DISPOSAL**

**Storage:** Store in a cool area away from heat and open flame. Store above 32°F and protect from freezing.

**Disposal:** Do not reuse empty container. Wrap original container in several layers of newspaper and discard in trash.

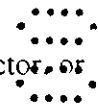
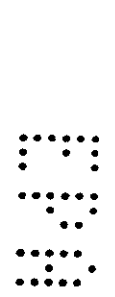
