To control fleas, ticks and lice on dogs and cats, dilute 4 ounces of concentrate with 1 gallon of water. Dip animal into solution, making sure hair is thoroughly wet to the skin. For control of ear mites, while dipping, lightly sponge inside of ears. Do not rinse. Towel dry. Repeat every 7 days, if needed.

Do not treat puppies or kittens under 4 weeks of age.

Consult a veterinarian before using this product on debilitated, medicated, aged, pregnant or nursing animals.

STORAGE AND DISPOSAL: Store in cool locked area. Protect from freezing. Do not reuse empty container. Wrap in several layers of newspaper and discard in trash.
