The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted with conditions.

#### **Proposed Amendment:**

Update label as PR Notice 2001-1

#### Other Comment(s):

- Revise your Precautionary Statement to read from most to least toxic route of exposure: "Harmful if swallowed. Harmful if absorbed through skin. Avoid contact with skin, eyes or clothing. Harmful if inhaled. Avoid breathing vapor. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse.
- 2. Revise your Directions For Use to be in agreement with PR Notice 2000-5 and FAD-1 as follows:
  - a. "Apply an initial slug addition of 2.53 to 6.33 fluid ounces of CHEMICAL TREATMENT CT-202 per 1000 gallons of water to provide a concentration of 20 to 50 parts per million....in the system. [delete *"is recommended"*] Repeat initial dosage until control is evident."
  - b. "When microbial control is evident subsequent slug additions of 0.63 to 6.33 fluid ounces of ..."
  - c. "...CHEMICAL TRETMENT CT-202 are [delete "should be"] employed every 2 to 5 days, or as needed. The frequency...'
  - d. "Slug additions are [delete "should be"] made in the sump of water cooling towers."
  - e. Prior to its use, systems *must* [delete "should"] be cleaned to remove bacterial slime and other deposits. Apply an initial... 1000 gallons of water. [delete "*is* recommended "]

An initial slug addition of 1.11 to 2.71 fluid ounces of CHEMICAL TREATMENT CL-2158 per 1000 gallons of water to provide a concentration of 9.6 to 24 parts per million of CHEMICAL TREATMENT CL-2158, based on the total weight of water in the system, is recommer Repeat initial dosage until control is evident.
