

# VC Alga-Cide 1

**DIRECTIONS FOR USE  
GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

VC Alga-Cide 1 is used to control the growth of algae in swimming pools, exterior spas, whirlpools, and hot tubs. For maximum effectiveness pools, spas, whirlpools, and hot tubs containing heavy growth of algae should be cleaned prior to using VC Alga-Cide 1.

For pools having just visible algae growth add an initial dose of 75 to 118 fluid ounces of VC Alga-Cide 1 per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool add initially 41 to 75 fluid ounces of VC Alga-Cide 1 per 10,000 gallons of water. Subsequent additions of 13.6 to 27 fluid ounces of VC Alga-Cide 1 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, or hot tubs having just visible algae growth require an initial dose of 8 to 12 fluid ounces of VC Alga-Cide 1 per 1000 gallons of water. For treatment of a freshly cleaned and filled spa, whirlpool, or hot tub, add initially 4 to 8 fluid ounces of VC Alga-Cide 1 per 1,000 gallons of water. Subsequent additions of 1 to 3 fluid ounces of VC Alga-Cide 1 should be made every 5 to 7 days after initial treatment for maintenance.

VC Alga-Cide 1 is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. VC Alga-Cide 1 can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix VC Alga-Cide 1 with concentrated dry or liquid chlorine products.

**STORAGE & DISPOSAL:** Keep container closed when not in use. Do not contaminate water, food, or feed by storage, disposal or cleaning of equipment. Rinsate that cannot be used or reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies. Open dumping is prohibited.

**METAL CONTAINERS:** Triple rinse and offer for recycling, reconditioning, or disposal in an approved landfill or bury in a safe place.

**PLASTIC CONTAINERS:** Do not reuse empty container. Triple rinse and incinerate or dispose of in an approved landfill or bury in safe place.
