

An initial slug addition of 5.1 _____ AQUACIDE E _____ per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.7 _____ AQUACIDE E _____ per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water control systems.

STORAGE AND DISPOSAL
