

GS1 820 DISINFECTANT

When used as directed, this product is an effective disinfectant, deodorant, and sanitizer. When used as a sanitizer, food contact surfaces, equipment, and utensils can be air dried after immersion in a 1 oz./4 gallon solution without a potable water rinse.

When used as directed, this product mixes with water to form clear, stable use solutions that are non-corrosive and non-staining to most common metals, plastics, and tile.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS DANGER

Causes eye damage and skin irritation. Do not get in eyes, on skin or on clothing. Harmful if swallowed. Avoid contamination of food. Avoid breathing spray mist.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not discharge into lakes, streams, ponds, or public water unless in accordance with an NPDES Permit. Do not contaminate water by cleaning of equipment or by disposing of wastes.

STORAGE AND DISPOSAL:

USE DIRECTIONS GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DISINFECTION IN HOSPITALS, RESTAURANTS, COMMERCIAL AND INDUSTRIAL OFFICES, RESTROOMS AND WORK AREAS. This product may be used on floors, walls, woodwork, bed frames, and furnishings. Types of surfaces suitable for disinfection include glass, smooth metal, washable painted wood or metal, vinyl, glazed porcelain, plastic, finished leather, finished wood and similar non-porous, hard, smooth surfaces.

Always pre-clean surfaces with a suitable detergent and rinse well with water before disinfection. After cleaning, apply a solution containing 1 ounce of Disinfectant per gallon of water for usual disinfecting applications. For disinfecting contact surfaces, use 1 1/2 ounces per gallon of water.

This product fulfills the criteria of Appendix F of the Grade "A" Pasturized Milk Ordinance 1965. Recommendations of the U.S. Public Health Service in waters up to 700 ppm of hardness calculated as CaCO₃ when tested by the A.O.A.C. Germicide and Detergent Sanitizers - "Official Method".

*This disinfectant is effective at 1 oz./gal. against *Pseudomonas aeruginosa* PRD-10, *Salmonella choleraesuis* ATCC 10708, and *Staphylococcus aureus* ATCC 6538 when tested by the A.O.A.C. Use Dilution Test Method for pre-cleaned, non-porous hard surfaces.

*This disinfectant is an effective virucide against Influenza virus, Type A, Brazil at 1 oz./gal. on pre-cleaned, non-porous hard surfaces.

When applied as directed to pre-cleaned hard, non-porous surfaces, this disinfectant also kills the following organisms at 1 ounce per gallon: *Candida albicans*, *Escherichia coli*, *Streptococcus pyogenes*, *Enterobacter aerogenes*, *Shigella sonnei*.

PRACTICAL TREATMENT (FIRST AID): In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. If swallowed, drink promptly a large quantity of milk, raw egg whites, gelatin solution or, if these are not available, drink a large quantity of water. Avoid alcohol. Call a physician immediately.
