Rainbow is used to control the growth of algae in swimming pools, exterior spas, whirlpools, and hot tubs. For maximum effectiveness pools, spas, whirlpools, and hot tubs containing heavy growth of algae should be cleaned prior to using Rainbow.

For pools having just visible algae growth add an initial dose of 75 to 116 fluid ounces of frainbow per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool add initially 41 to 75 fluid cunces of Rainbow per 10,000 gallons of water. Subsequent additions of 13.6 to 27 fluid ounces of Rainbow per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, or hot tubs having just visible algae growth require an initial dose of 8 to 12 fluid ounces of Rainbow per 1000 gallons of water.
