This special formula contains a long lasting fungicide (Copper 8 Quinolinolate) along with special additives that seal out deterioration caused by moisture and the orisional of environmental elements. This Semi-Transparent Stain is designed for use on exterior siding, fences, and wood seriores. Due to its penetrating and absorbent features, the natural texture and grain of the wood will be enhanced.

How To Use

Semi-Transparent Stain and Wood Preservative is ready for use. Do not use thinner. Stir thoroughly before using and occasionally while applying.

All surfaces should in thoroughly clean and dry before staining. Unsightly midlew stains should be scrubbed with a solution of 1 quart household blooch to 3 quarts of warm water. Let stand for 30 minutes, then rinse with water. When surface is dry, liberally apply stain by brush, roller, pad applicator or spray. To eliminate lap marks, apply to only a few boards at a time, working from top to bottom or from side to side, stopping only at locations as corners, windows, or door frames. Avoid using in direct sunlight. Do not apply if temperature is below 50°F. Dries to touch rapidly. Thorough drying will take 24 hours. If necessary, a second coat may be applied at any time. In addition, the greater the amount of stain absorbed by the wood the more effective the protection.

Coverage

A gallon will treat 100-200 square feet on rough or unfinished surfaces and 100-300 square feet on previously scaling or finished surfaces

Clean-Up

Clean brushes and equipment with mineral spirits or other suitable paint thinners.

Meets or exceeds water repellency requirements of U.S. Federal Specification TT-W-572b, 3.7.

Color of chip represented on front panel could vary with the number of coats applied, the color of the surface covered, and the method of application
