STATEMENT OF PRACTICAL TREATMENT: In case of skin contact, wash with plenty of soap and water. Remove contaminated clothing and wash before reuse. If product is swallowed, call a physician immediately. If patient is conscious, induce vomiting by stroking or tickling the patient's throat or far back on patient's tongue. Ematica such as 2 teaspoonsful (10 mL) of ipecae syrup or 1 teaspoonful (5 mL) of dry mustare in warm water to form a paste or even soap in warm water can be used. Repeat until vomit fluid is clear. Then have patient drink plenty of milk, gelain solution, beaten egg whites, flour and water, or other nonoily demulcent. Never induce vamiting or give anything by mouth to an unconscious

#### **DIRECTIONS FOR USE GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

CGS Microbicide-2 is used in cooling water systems and industrial air-washing systems to control microbiological slime. In cooling systems, add 3.4 to 10.3 ft, oz. of CGS Microbicide-2 per 1000 gal. of water to the cooling tower sump. In air-washing systems, add 12 to 20.5 fl. oz. of CGS Microbicide-2 per 1000 gal, of water to water-collection trays. Repeat treatments every 1-5 days, or as needed. The required frequency depends on relative amount of bleed and severity of slime problem.

#### STORAGE AND DISPOSAL

PROHIBITIONS: Up not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

PESTICIDE DISPOSAL: Pesticide, spray mixture, or rinsate that cannot be used or chemically reprocessed should be disposed of in a landfill approved for pesticides, or buried in a safe place away from water supplies.

#### **CONTAINER DISPOSAL:**
