Ultra-Life is a clear interior and exterior wood preservative that protects and enhances the natural beauty of wood. Provides positive protection against decay, fungi staining and warping. Ultra-Life Clear is an odorless, non flammable water repellent that reduces swelling and shrinking. Ultra-Life will not adversely affect plant or animal life and is safe for use in food processing operations not in direct contact with food products. When dry, Ultra-Life provides a repaintable surface for the subsequent application of paints, stains, enamels or varnishes if desired. Ultra-Life increases top coat resistance to peeling and blistering. Ultra-Life has a very low odor and may be applied to interior surfaces without appreciable discomfort to occupants.

**USES:** Brunings Ultra-Life Wood Preservative is highly recommended for wood and wood products. Ultra-Life lengthens the life and protects shingles, millwork, windows, siding, doors, fences, outdoor furniture, structural lumber, docks, piers, posts and pilings.

**SURFACE PREPARATION:** Be sure that the surface to be treated is clean and free of all dirt, bark, wax, grease or grime. Be sure that the wood is dry and well seasoned. Wipe off dust with a clean tack rag.

**NEW OR UNTREATED WOOD:** For small areas apply by brush, roller, conventional or airless spray. Dipping is recommended where possible. Side or end grains should be coated two or three times for full protection. Lumber intended to come in contact with the soil should be dipped for a minimum of three minutes. Heavy lumber such as fence posts, poles, foundation timbers and other large wooden members should be dry, well seasoned and free of bark or dirt. It is suggested that such large lumber be immersed in Ultra-Life Clear for a period of 12 to 48 hours before being used.

**TECHNICAL DATA:** Apply as it comes from the container. Appearance in container is milky white, but Ultra-Life dries to a clear flat finish. Spread at a rate of 150-200 square feet per gallon depending upon porosity of surface and method of application.
