

This product is a phosphate free cleaner designed specifically for hospitals, nursing homes, schools, day care centers and other institutions where housekeeping is of prime importance in controlling the spread of cross contamination. This product when diluted at the rate of 2 ounces per gallon of water is effective against *Pseudomonas aeruginosa* and meets all requirements for hospital use. When used as directed, this product is formulated to disinfect inanimate hard surfaces such as walls, floors, sink tops, toilet bowls, shower stalls, telephones, bed frames, operating rooms, patient care facilities and restrooms. This product disinfects garbage storage areas, empty garbage bins and cans, toilet bowls and any other areas which are prone to odors caused by microorganisms.

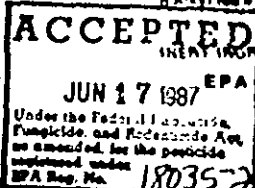

Statement of Practical Treatment

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with the labeling.

DISINFECTION: To disinfect hard inanimate surfaces (such as walls, floors, table tops), add 2 ounces of this product per gallon of water. Dilution with soap, cloth, or sponge or mechanical sprayer so as to wet thoroughly. Allow to remain wet for 10 minutes, and then let air dry. For heavily soiled areas, a pre-cleaning step is required and recommended. Prepare a fresh solution for each use.

MILDEWSTAT: To control mildew and mold on pre-cleaned, hard non-porous surfaces (such as floors, walls, table tops) add 2 ounces of this product per gallon of water. Apply solution with a cloth, mop, or sponge making sure to wet all surfaces completely. Let air dry. Prepare a fresh solution for each use. Repeat application at weekly intervals or when mildew growth reappears.

DISINFECTION: At 2 ounces per gallon dilution, this product exhibits effective disinfectant activity against the following:

At this level the product is also fungicidal against the pathogenic fungi, *Trichophyton mentagrophytes*.

VIRUCIDAL* ACTIVITY: The product when used on environmental inanimate hard surfaces at 2 ounces per gallon of water exhibits effective virucidal* activity against influenza A2-Astria (representative of the common flu virus), Herpes simplex (causative agent of fever blisters and mononucleosis), Adeno virus type 2 (causative agent of upper respiratory infections), and vaccinia virus (representative of the pox virus group).

MOLD and MILDEWSTAT: This product controls mold and mildew and the odors they cause on hard non-porous inanimate surfaces.
