

# CONTRACT

HIRED TO KILL BUGS

### HAZARDS TO HUMANS AND DOMESTIC ANIMALS:

May be harmful if swallowed, inhaled or absorbed through skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes or clothing should also be avoided. Wash thoroughly after handling. Avoid contamination of food utensils and food preparation areas. Should illness occur, obtain prompt medical aid. Atropine Sulfate is antidotal.

Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Do not spray on vegetation.

Remove pets and cover fish bowls before spraying. Do not allow children to contact treated areas. Surfaces are thoroughly dry.

If Inhaled: Remove victim to fresh air.

If In Eyes: Flush with plenty of water. Call physician immediately.

If On Skin: Wash affected area with soap and water. Remove contaminated clothing.

### DIRECTIONS FOR USE:

It is a violation of federal law to use this product in a manner inconsistent with the labeling.

Ants, Roaches, Silverfish, Spiders, Crickets, Scorpions, Saw-toothed Grain Beetles (exposed stage): Spray anywhere these insects may hide-cracks, crevices, around baseboards, beneath cabinets, refrigerators, sinks, stoves and in waste receptacles. For ants spray trails and places where ants enter premises. Repeat as needed. Brown Dog Ticks: Spray sleeping quarters of pets. Place fresh bedding in pets quarters after spraying. Repeat as needed. Do not spray animals. Clover Mites, Earwigs, Fleas, Flies, Mosquitoes, Sowbugs in out of door areas: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios or other places where insects may enter. Repeat as needed.

### PHYSICAL AND CHEMICAL HAZARDS:

Flammable Mixture: Do not spray into or near open flame. Do not smoke while spraying.

**STORAGE AND DISPOSAL:** Store in an area away from excessive heat. Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard in a safe place away from water supplies.
