A single application removes dirt and grime, disinfects, is virucidal, fungicidal, and will prevent the growth of mold and mildew and their odors. When used as directed, the hard surface disinfecting action of SAN-I-SCRUB will reduce the hazard of cross-contamination. SAN-I-SCRUB is also an extremely effective one-step sanitizer for non-food contact surfaces. When used as directed, SAN-I-SCRUB will deodorize surfaces in toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas, and other places where bacterial growth can cause mal odors.

Statement of Practical Treatment

GENERAL CLASSIFICATION

SAN-I-SCRUB is a proven "one step" cleaner, disinfectant sanitizer fungicide mildewstat virucide in the presence of moderate amounts of organic soil.

Apply SAN-I-SCRUB to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks and bedframes with a cloth mop or mechanical spray device so as to thoroughly wet surfaces.

Preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty

Disinfection—to disinfect hard, non porous surfaces, add 2 oz. per gallon of water. Treated surfaces must remain wet for 10 minutes

The activity of SAN-I-SCRUB has been evaluated in the presence of 5% serum by the AOAC use dilution test and found to be effective against a broad spectrum of gram negative and gram positive organisms as represented by:

- Escherichia coli
- Salmonella choleraesuis
- Staphylococcus aureus
- Streptococcus pyogenes
- Serratia marcescens
- Salmonella typhi
- Klebsiella pneumoniae
- Salmonella schottmulleri
- Shigella dysenteriae
- Brevibacterium ammoniagenes

Fungicidal Performance—SAN-I-SCRUB is effective against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, shower and bath areas, exercise areas, dressing rooms, etc. at 2 oz. per gallon

Mold and Mildew Control—At 2 oz. per gallon SAN-I-SCRUB will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns

Virucidal Performance—At 2 oz. per gallon use level SAN-I-SCRUB was evaluated in the presence of 5% serum and found to be effective against the following viruses: Influenza A/Brazil, Herpes Simplex, and Vaccinia on inanimate environmental surfaces

Sanitizing Non Food Contact Surfaces such as floors, walls, tables, etc. At 5 oz. per 4.5 gallon use level, 30 second contact time, SAN-I-SCRUB is an effective sanitizing agent against Staphylococcus aureus and Klebsiella pneumoniae in the presence of 5% serum on porous and non porous environmental surfaces.
