



The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

1. Move the "KEEP OUT OF REACH OF CHILDREN" to a position appearing immediately above the front panel signal word.
2. Note the minimum type size requirements for the "KEEP OUT OF REACH OF CHILDREN".
3. In answer to the question posed by your letter you may reduce the precautionary labeling section to read as follows:

"PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

"Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid inhalation of vapors. Children and pets should not be allowed in treated areas until sprayed surfaces are dry. Wear synthetic rubber/PVC gloves when applying. Press white valve base only after insertion of the nozzle into flight holes; turn white pressure surface away from eyes. Do not use for purposes other the woodworm control."

"PHYSICAL OR CHEMICAL HAZARDS

Flammable! Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130° may cause bursting."

(Follow with STATEMENT OF PRACTICAL TREATMENT as it now reads.)

4. Immediately following the heading "DIRECTIONS FOR USE" insert the following: "It is a violation of Federal law to use this product in a manner inconsistent with its labeling."
5. Delete the "s" from "Active Ingredients" since there is only one ingredient.

If you hold a Federal registration, a supplemental registration, or a Special Local Needs registration, you may continue to produce new stocks of such products, using current labeling, until May 31, 1984. After that date, all remaining inventories of affected products will fall under the Existing Stocks provisions stated in our letter of October 28, 1983.
