ACCO Algaecide 30 Concentrate-L is used to control the growth of algae in swimming pools, exterior spas, whirlpools, and hot tubs. For maximum effectiveness, pools, spas, whirlpools, and hot tubs containing heavy growth of algae should be cleaned prior to using this product. For pools having just visible algae growth, add an initial dose of 23.5 to 36.4 fluid ounces of this product per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool, add initially 12.8 to 23.5 fluid ounces of this product per 10,000 gallons of water. Subsequent additions of 4.3 to 8.6 fluid ounces of this product per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance. Spas, whirlpools, or hot tubs having just visible algae growth require an initial dose of 2 to 4 fluid ounces of this product per 1,000 gallons of water. For treatment of a freshly cleaned and filled spa, whirlpool, or hot tub, add initially 1 to 2 fluid ounces of this product per 1,000 gallons of water. Subsequent additions of 0.5 to 0.8 fluid ounces of this product should be made every 5 to 7 days after initial treatment for maintenance. This product is compatible with those chemicals normally used to treat pools and spas and is effective in both acid and alkaline pH.
