ALPHA-G protects crops against seed-borne diseases such as stinking smut of wheat, oat smut, covered and false loose smut of barley, and bunt of rye. It also gives temporary protection to cereal grains, corn, and soybeans against soil-borne diseases such as root rot and seedling blight. Lindane temporarily protects seed and seedlings against wireworms.

DIRECTIONS FOR USE

Thoroughly mix ALPHA-G with seed in the planter box or with a mechanical dust treater. DO NOT MIX WITH HANDS.

WHEAT-BARLEY-OATS-RYE: Use rate of 2 Oz. per bushel

FLAX: Use rate of 4 Oz. per bushel

CORN-SOYBEANS: Use rate of 2.75 Oz. per bushel

For maximum benefits, use well cured, dry and clean seed at the recommended rate and avoid deep seeding and early sowing under poor field conditions.

WARNING

STATEMENT OF PRACTICAL TREATMENT

If swallowed-Call a physician or Poison Control Center immediately. Drink one or two glasses of water and induce vomiting by touching the back of the throat with finger. If possible, vomiting should be induced under medical supervision. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person.

If inhaled-Remove victim to fresh air. Apply respiration if needed.

If on skin-Remove contaminated clothing and wash with soap and water.

If in eyes-Flush eyes for at least 15 minutes with water. Call a physician if irritation persists.

STORAGE AND DISPOSAL

1. PROHIBITIONS: Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.
