FIRST AID

IF SWALLOWED: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious person.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. This pesticide may be used only for the formulation of an insecticide. Formulators using this product are responsible for obtaining EPA registration for their formulated product. Refer to Technical Bulletin for formulating and other information.

This technical product may be formulated into and use products solely for the uses listed below:

Treatment of seeds for the following agricultural crops: barley, broccoli, brussels sprouts, cabbage, cauliflower, celery, collards, corn, lettuce, kale, kohlrabi, mustard greens, onion, radishes, rye, sorghum, spinach, Swiss chard and wheat.

Treatment of stored timber and lumber (in industrial wood processing facilities only - no open forestry use).

Treatment of dogs to control fleas, ticks, lice, earmites, sarcoptic mange mites and scabies (psoroptic) mange mites.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

STORAGE INSTRUCTIONS: Storage should be under lock and key and secure from access by unauthorized persons and children. Storage should be in a cool, dry area away from any heat or ignition source. Do not stack over 2 pallets high. Do not move containers from one area to another unless they are securely sealed. Keep containers tightly sealed when not in use. Do not allow material to become wet or store in a damp, humid area. Keep away from any puncture source. Avoid storage near water supplies, food, feed and fertilizer to avoid contamination. Store in original container only. If contents are leaking or material is spilled, follow these steps:

1. Collect and place in suitable containers for disposal.
2. Wash area with soap and water to remove remaining pesticide.
3. Follow washing with clean water rinse.
4. Do not allow runoff to enter sewer or contaminate water supplies.
5. Dispose of waste as indicated below.
