AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard (WPS), 40 CFR Part 170. This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, greenhouses and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted entry interval (REI). The requirements in this box only apply to uses of this product that are covered by the WPS.

Do not enter or allow worker entry into treated areas during the REI of 24 hours.

PPE required for early entry to treated areas that is permitted under the WPS and that involves contact with anything that has been treated, such as plants, soils or water is: Long-sleeved shirt and long pants, chemical-resistant gloves made of any waterproof material, and shoes plus socks.

LEVEN-38 is a contact and systemic sucker control agent which with one application kills small suckers on contact within one-half to one hour after application and then works systemically on the Tobacco plant to control cell subdivisions and the formation of new suckers. This product is formulated exclusively for the control of Tobacco suckers.

This product can be applied by conventional spray mechanisms. Use a semi-coarse spray and spray one or more rows at a time wetting only the upper 0.33 to 0.5 of the Tobacco plant and allowing the liquid to run down the stalk of each plant, using only about 20 pounds of pressure. Plants that are leaning must be straightened so that the spray flows down the stalk evenly and contacts each sucker.

This product should be applied during the early morning after the dew dries, all day on cloudy days, avoiding late afternoon or night applications. Spraying during the bright noon day sun at atmospheric temperatures above 90°F should be avoided since injury to the top tender leaves may result.

Do not apply this product when the wind velocity is high enough to turn over the top leaves since injury may result from the application to the tender underside of the Tobacco leaf. Do not apply during a rain or when the leaves are still wet or when rain is predicted during the period of 12 hours following application. The contact agent in the formulation is effective within one hour after spraying, but the systemic agent requires about 6 hours for absorption throughout the entire plant and rain within that period may reduce effectiveness. If applied during drought, the contact portion of the formulation continues to function normally, but the systemic sucker control action may be reduced because of the diminished absorption capabilities of the Tobacco plant under drought conditions.

BURLEY TOBACCO

Top the Tobacco plants when they are at about the full-flower stage and remove, by hand, all suckers which are over one inch. The plants should be sprayed promptly (within one day after topping). Add 9 quarts of this product to 10 to 20 gallons of water and with the mixer running, add more water to bring the volume up to a total of 50 gallons. Operate the sprayer at a speed of 2.5 to 3 miles per hour and apply 50 gallons of diluted emulsion per acre of Tobacco. Use a semicoarse spray covering the top one-third to one-half of the plant and allowing the liquid to run down the stalk to the bottom of each plant using only about 20 pounds of pressure. For the compressed air shoulder sprayer, use 1 pint of this product per 3 gallons of water and mix well before using. Apply at a rate of 3 gallons of diluted emulsion per 667 plants, agitating the solution from time to time during sprayinc.

Make sure the content of this product is well-mixed and shaken before measuring.

FLUE-CURED TOBACCO

Apply this product, after topping, at early flower (one week after button). Remove, by hand, all suckers which are over one inch. The plants should be sprayed promptly. Add 12 quarts of this product to 10 to 20 galions of water and with the mixer running, add more water to bring the volume up to a total of 50 galions. Operate the sprayer at a speed of 2.5 to 3 miles per hour and spray 50 galions of diluted emulsion per acre to Tobacco. Use a semi-coarse spray covering the top one-third to one-half of the plant and allowing the liquid to run down the stalk to the bottom of each plant, using only about 20 pounds of pressure. Make sure the content of this product is well-mixed and shaken before measuring. NOTES:

 Do not apply within 7 days prior to harvest to minimize residue. It is recommended that no more than one application be applied to assure low residue levels. 6

- Do not mix this product with any other chemicals or agents. Apply separately and do not apply to plants which have been recently treated with insecticides.
- Mix well prior to use and, if allowed to stand during the use, mix again before applying since the diluted emulsion may separate on standing.
- Do not use on Burley tobacco during periods of high heat and humidity or under conditions which favor the spread of Tobacco diseases.
- Make sure that the spray equipment is clean before use. Do not contaminate water by cleaning of equipment or disposal of wastes.
- 6. Do not use on seed Tobacco.
- 7. Do not allow drift to nearby crops.
- Usage according to the directions outlined has resulted in adequate sucker control with very little or no leaf injury. Application not in accordance with the directions may lead to injury of leaves or improper sucker control.
- 9. This label must be in the possession of the user at the time of pesticide application.

STORAGE AND DISPOSAL
