If on skin, wash promptly with soap and water. Rinse thoroughly.

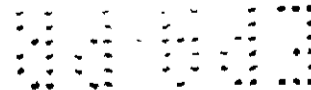
If in eyes, rinse eyes with water and call a physician immediately.
