

# STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

#### STORAGE:

Storage should be under lock and key and secure from access by unauthorized persons and children. Storage should be in a cool dry area away from any heat or ignition source. May be ignited by heat or open flame.

Do not stack over 2 patiets high. Move bags carefully so as not to tear or puncture. Do not move containers from one area to another unless they are securely sealed.
